Terms between subcontractor and BIRN Group, hereinafter referred to as BIRN customer specific requirements to suppliers.

BIRN group's main goal in cooperation with its suppliers is to ensure that the delivered products/services comply with the BIRN Group & End-customer's requirements and expectations.

Human Rights

The supplier is encouraged to adhere to the "OECD Guidelines for Multinational Enterprises". (OECD = Organization for Economic Cooperation and Development), see www.oecd.org.

Records Viewing

The supplier must have a process to ensure timely review, distribution and implementation of all BIRN Group & End-customer standards/requirements and changes, based on the BIRN Group's schedule. Timely review must take place as soon as possible and must not exceed 2 working weeks. Exceptions are suppliers who deliver a standard product which is specified by the supplier themself.

Spare Parts

The supplier must be able to perform and deliver products/services 15 years after series production has stopped, unless legal restrictions prohibit the use of the process and/or items. Excluded are products used in the manufacturing process at BIRN group (such as scrap, sand, additives etc.).

Shipping and Invoicing

The date of the Dispatch Advise (Advance Shipment Notification) or invoice is regarded as the delivery day when transport conditions are DDP (Delivered Duty Paid); DAP (Delivered At Place) or EXW (EX-Works).

Invoices must at least contain item description, unit price, number of units, delivery note number as well as order number.

Delivery notes must contain both BIRN's item and order number. Exempt are suppliers who carry out self-billing.

Orders/Order Confirmation

The price of the goods/services written on an order confirmation sent to BIRN, must match the price of the goods/services written on the order sent to the supplier, otherwise the confirmation is considered as a new offer and thus the order placed is not valid. Suppliers who carry out self-billing are exempt from using order confirmations.

Package Material Handling

Not End-customer specific packaging will be billed at agreed prices.

End-customer specific packaging. Some End-customers do not have any form of registration of their packaging. If there should be a need for traceability of packaging quantities used for the various suppliers, BIRN will register each delivery note.

Shipping

By the shipment type ex-works shipment must be made with a forwarder appointed by BIRN. The freight forwarder shall be advised with the quantity and time of pickup at least 24 hours before collection.
